

## State aid continued to increase in Spain during 2021

- Each year, the CNMC publishes an annual State Aid Report, based on the latest data from the European Union (EU) <u>State aid Scoreboard</u>.
- In 2021, the granting of aid reached 1.69% of GDP compared to 1.28% in 2020.
- Spain ranked 19th in the European Union in terms of aid as a percentage of GDP.
- 61% of the aid granted was aimed at mitigating the effects of the Covid-19 crisis.

**Madrid, 20 December 2023-.** The National Markets and Competition Commission (CNMC) has submitted to the Spanish Parliament the **Annual Report on State Aid for 2023** (<u>IAP/CNMC/001/23</u>).

The CNMC **monitors state aid** in order to identify whether there are unjustified distortions in the markets, thereby helping to safeguard their proper functioning.

## Conclusions

The **analysis of aid granted in Spain covers the year 2021**, the last year for which the EU <u>State aid Scoreboard</u> provides data.

- Aid granted in Spain increased compared to 2020 (1.69% of GDP in 2021, compared to 1.28% of GDP in 2020).
- In the EU, there was a slight decrease (from 2.30% in 2021 to 2.38% in 2020).
- Spain ranked **19th in the EU** in terms of aid as a percentage of GDP, 20.447 billion euros.
- 61% of aid (1.03% of GDP) was spent to mitigate the effects of the Covid-19 pandemic. In the EU, this percentage amounted to 57% (1.31% of GDP).
- 61% of Covid-19 aid was channelled through guarantees. Spain is one of the countries that made most use of this instrument as opposed to subsidies.

- Regional development was one of the main objectives of aid, including aid to individual consumers (42%), compared to the rest of the EU (11%).
- The weight of aid dedicated to the environment and energy efficiency was 41% (less than 10% in 2020) compared to 55% for the rest of the EU.
- Since 2014, no new aid has been granted to the financial sector in Spain.
- "De minimis" aid, not included in the EU <u>State aid Scoreboard</u>, represented a total aid equivalent higher than EUR 1.5 billion (0.13% of Spain's GDP in 2021).

## Other aspects of the report

- Regulatory developments and administrative and judicial decisions of EU authorities in 2022 in the area of state aid:
  - Temporary Crisis and Transition Framework, providing greater flexibility for Member States to implement aid programmes.
  - Regulation on foreign subsidies distorting the internal market.
  - Guidelines on State aid for climate, environmental protection and energy.
- The CNMC's aid activity in 2022, with the study of aid for broadband roll-out granted between 2013 and 2020 (<u>EI/01/2022</u>). The activity of the regional competition authorities is also covered.

The CNMC is the independent body that oversees the markets and guarantees and promotes effective competition. This report is issued ex officio in accordance with art. 11.2 of Law 15/2007 of 3 July, on the Defence of Competition.
